Anti Ragging Cell

As per the guidance of University Grants Commission under the Act of 1956, which is modified as UGC regulation on curbing the ragging in higher educational institutions 2009, establishment of Anti Ragging Cell is very Compulsory. Anti Ragging Cell should be one of the important cells in an institution.

Objectives of Anti Ragging Cell

1. To create a culture of ragging-free environment in the college.
2. To Prevent, Prohibit, and Redress any forms and instances of Ragging in the College.
3. To educate the students on the meaning of ragging and what constitutes it.
4. To bring out an awareness among the students about the consequences of ragging.

In exercise of the powers conferred by Clause (g) of Sub-Section (1) of Section 26 of the University Grants Commission Act, 1956, the University Grants Commission here by makes the following Regulations

Punishable ingredients of Ragging: Abetment to ragging as per

- Criminal conspiracy to rag;
- Unlawful assembly and rioting while ragging;
- Public nuisance created during ragging;
- Violation of decency and morals through ragging;
- Injury to body, causing hurt or grievous hurt;
- Wrongful restraint;
- Wrongful confinement;
- Use of criminal force;
- Assault as well as sexual offences or unnatural offences;
- Extortion;
- Criminal trespass;
- Offences against property;
- Criminal intimidation;

- Attempts to commit any or all of the above-mentioned offences against the victim(s);
- Physical or psychological humiliation;
- All other offences following from the definition of "Ragging".

As per the order of Supreme Court of India and subsequent Notification from University Grants Commission (UGC), ragging constitutes one or more of any intention by any student or group of students on:

1. Teasing, treating or handling with rudeness a fresher or any other student
2. Indulging in rowdy or indisciplined activities by any student
3. Asking any student to do any act from freshers cause for psychological harm
4. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
5. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
6. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
7. Any act of physical abuse harm or any other danger to health or person.
8. Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively for any student
9. Any act that affects the mental health and self-confidence.

Punishment Against Ragging

- Institution can suspend student from the course for a period.
- Cancellation of admission.
- There is no permission to attend classes and academic privileges.
- Permission is not given to write test/examination'
- Withhold results, scholarships and other benefits.
- Permission is not given to attend campus interviews/recommendations etc
- Fine for the student.
- If the person is not identified, the institution shall give collective punishment.
